ABOUT THE FRAMEWORK

The Construction Consultancy framework was tendered under 3 different regions across Wales – South, Mid and North Wales. Applicant companies were able to select the region(s) they wished to apply for and were assessed individually on the basis of their competence, skills and experience to undertake the services required in their selected region(s).

Companies were also able to apply for individual services or a combined consultancy service. For the combined consultancy services, companies were required to be able to offer all services, either directly or through sub-contractors. Through our rigorous evaluation process, we appointed 42 companies who offered best value for money for their services.

The service provision offered through our Construction Consultancy Framework covers the full range of RIBA stages 0-7 to support building projects from site find, survey and feasibility through to design, project management and completion.

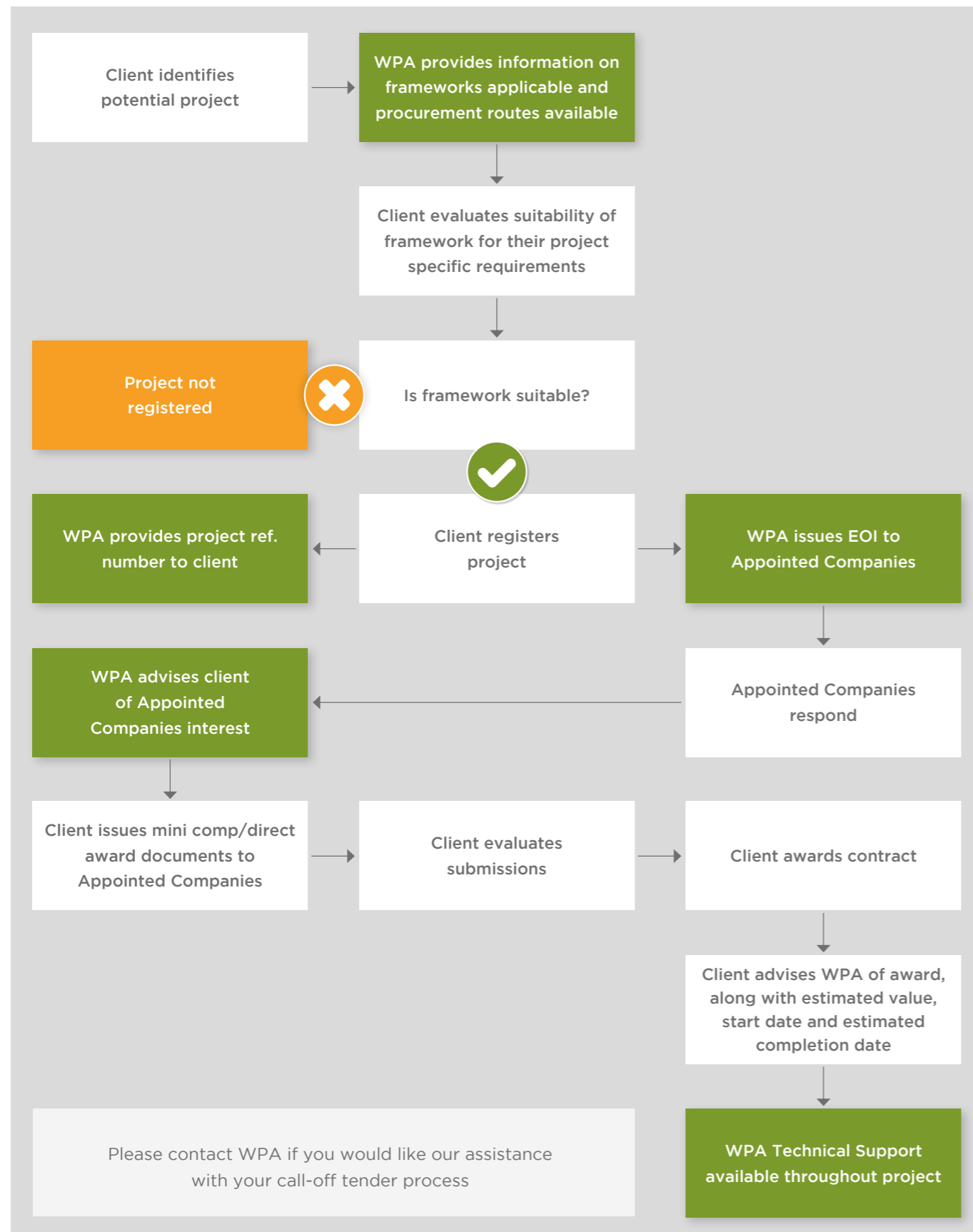
REGULATORY AND STATUTORY COMPLIANCE

Appointed companies were required to ensure compliance with all current statutory requirements in relation to carrying out their obligations.

They were also required to be registered members of the appropriate professional body and at least one person in each company was required to have chartered status.

Relevant organisations include: the Architects Registration Board, Institution of Structural Engineers, Institution of Civil Engineers, CIBSE, MRICS Quantity Surveying, NEBOSH, and Institute of Clerk of Works.

Combined consultancy services must offer all of the services listed 'a' to 'k' above and can offer any of the additional services that may be required by the client.

CALL-OFF AWARD OPTIONS

The framework allows clients the option of:

Direct award without further competition, where all terms and conditions of the call-off project are within the terms and conditions of the framework

OR

Mini-competition, where terms and conditions of the call-off may vary or be modified from the framework or at the choice of the Client.

When calling-off projects, clients can use any one of a range of standard agreements issued by professional institutions or their own modified versions.

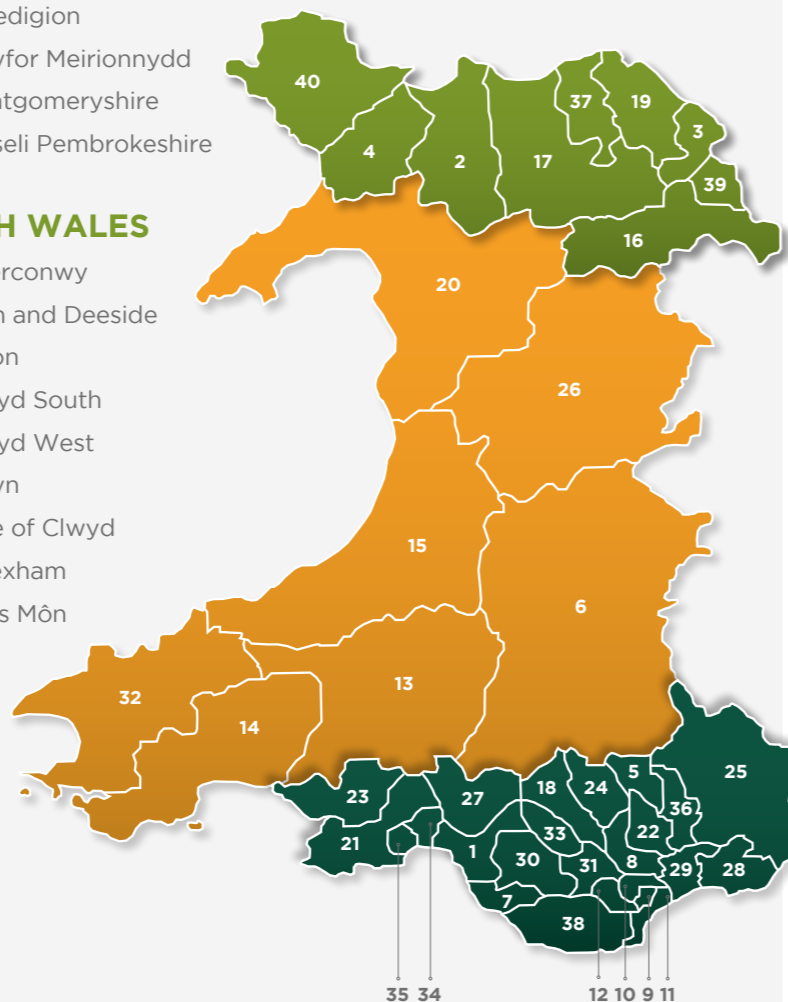
